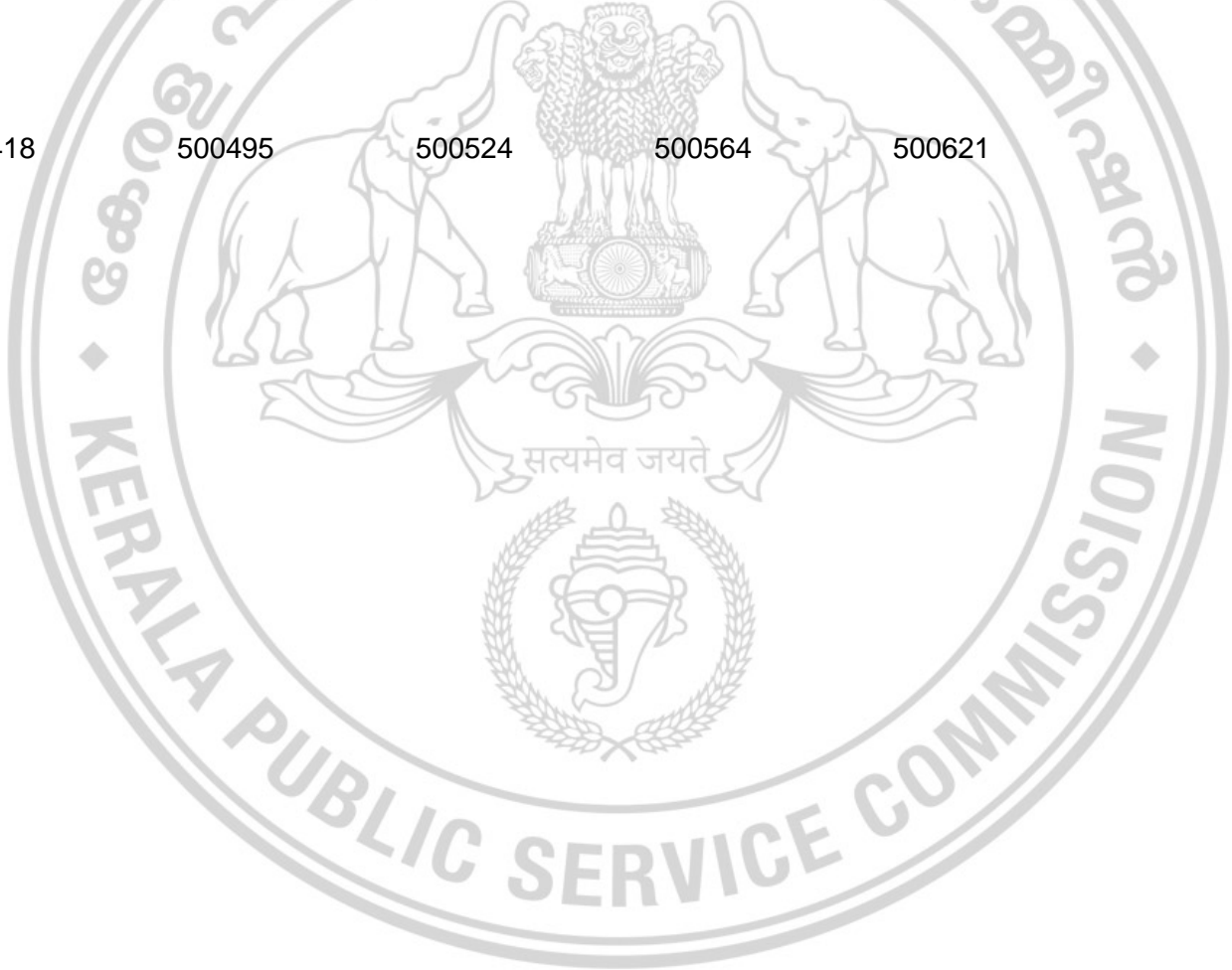

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 issued by the Revenue authority and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (7) Scanned image of Tabulation sheet and answer scripts of the Descriptive Test held on **01-09-2025 and 02-09-2025** will be issued to only those candidates who had attended all the Three Papers , who apply for the same, remitting the prescribed fee after approval of the Ranked List.
