**NOTE (1) :-** According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration profile from The Commissions official Website, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of rs.85/- (Rupees Eightyfive only).The fee can be remitted by e-payment through the portal.Application submitted in any other manner ie.via.Email/Tappal/Direct Etc.will not be considered.A period of 15(Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploadedin the website of the Commission.

**NOTE (2) :-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall shall submit Online Application hrough their One Time Registration profile from The Commissions official Website, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15(Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploadedin the website of the Commission. Application submitted in any other manner ie.via.Email/Tappal/Direct Etc.will not be considered.A copy of the Answer Script will be issued only once to a candidate.Copies of OMR Scripts invalidated due to any defect wil not be issued. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted ,the copy of OMR Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for wcich the candidate has participated.

**NOTE (3) :-** The entries put in column (7) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents.

**NOTE (4) :-** The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an Application in the format prescribed by the Commission addressed to District Officer ,Kerala Public Service Commission, District Office, Alappuzha either directly or by post.The format is available in the Official website of the Commission.The request for relinquishment in respect of those who do not submit the Relinquishment application in the format prescribed by the Commission will not be honoured under any circumstance.The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of uploading Ranked List up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (5) :-**Since a Common OMR test with common candidates was conducted for this post, the mark awarded to the candidates included in the Ranked List and mark of OMR Test relating to all candidates appeared for the test will be published only after the publication of the entire Ranked List(including NCA Notification).which wil be finalised on the basis of the Common Test.The result of rechecking of OMR answer sripts will be intimated in due course.But photocopy of OMR Answer Scrpts will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the common test.

**Note (6) :-** The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list finalised on the basis of the Common Test held on 17.05.2025.
