Note :- (4) Candidates included in the Short List who qualify in the Practical Test should present and produce in person the original documents for One Time Verification. Date, time and Venue of Practical Test & OTR Verification will be intimated through profile

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note(6) Candidate included in the Short List are required to produce Non Creamylayer Certificate issued by the Revenue authority at the time of OTR Verification. Candidates are required to produce latest extract of Driving Licence at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:- ER7-2/14/2025-KPSC DATED 12/11/2025
