Note :- (3) **12 (Twelve)** candidates who have secured top marks in the OMR examination are included in the Mainlist of the Probability List .The marks secured by the last candidate in the Mainlist of the Probability List is **55.67 (fifty five (point) six seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste ,Scheduled Tribe,Other Backward Classes(and other reserved categories,if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidate belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note:- (5) The Register number of candidates who do not produce required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Probability List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/19/SCSTD dated 26.09.2009 . SC/ST candidates are required to produce Community Certificate Either in Form III or digitally signed Certificates by the Revenue authority not below the rank of Tahsildar and candidates belonging Economically Weaker Section are required to produce Income and Asset Certificate issued by the Village Officer in the format prescribed vide G.O (MS) No.2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other relevant document at the time of One Time Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **11-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated for the above mentioned post.
