For the purpose of satisfying the Rules of Reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, EWS, necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (6) Candidates included in the Probability List are required to produce NCLC/ Community Certificate/EWS certificate issued by the Revenue authority at the time of OTR Verification as applicable to them.

Note :- (7) The Register Number of those candidates who do not produce the required documents within the prescribed timelimit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on **22-09-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated for this post vide Invalidation Notification No:- OSM-02/11/2025-kpsc dtd 08/01/2026
