

Note 1: The inclusion of Register Numbers in this list is provisional and subject to the scrutiny and acceptance of the application on an absolute basis. Being included in the Short List does not guarantee inclusion in the Ranked List.

Note 2: 25 (Twenty Five) candidates who have secured topmost marks in the Common Main OMR Examination held on 26.08.2025 are included in the Main List of the Short List. The marks secured by the last candidate in the main list is 55 (Fifty Five) .For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note 3: Candidates included in the Short List must appear in person to provide original documents for the Practical Test (T Test & Road Test) and One-Time Verification. The date, time, and venue for these tests will be communicated through Profile Messages/SMS in due course.

Note :4 Candidates must possess a valid Driving License with endorsement for driving Heavy Goods vehicle, Heavy Passenger Vehicle with badge throughout all stages of selection, i.e., on the last date for receipt of Application, Date of OMR Test and Date of Practical Test

Note : 5 The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose Applications are found otherwise defective will be deleted from the Short List without further notice.

Note 6: As per the current procedure, revaluation of answer scripts is not permitted. However, candidates may request a recheck of their answer scripts after the publication of the Ranked List. Detailed instructions will be issued along with the Ranked List.

Note 7: Candidates included in the Short List and belonging to Other Backward Classes (OBC) must present a Non-Creamy Layer Certificate issued by the Village Officer as per GO(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates must present a Community Certificate issued under Rule 4 of the Kerala (SC/ST) Regulations by a Revenue Authority not below the rank of Tahsildar. Candidates claiming reservation under the Economically Weaker Section (EWS) category must provide an Income and Asset Certificate issued by the Village Officer as per GO(Ms) No. 03/2024/P&ARD dated 25.04.2024, along with other relevant documents, during the One-Time Verification.

Note 8: Candidates who wish to obtain a copy of their OMR answer script from the test held on 26-08-2025 may apply for the same by paying the prescribed fee after the approval of the Ranked List. As per Notification No: ER7-2/14/2025-KPSC dated 12.11.2025, no answer scripts have been invalidated.
