Note :- (2) The Short List has been prepared based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) The candidates who have secured **79 ( seventy nine )** marks in the OMR Examination for the post held on 26.08.2025 are included in the Main List of this Short List . For the purpose of satisfying the rules of reservation of appointments to Scheduled Caste, Scheduled Tribe and Other Backward Classes (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) **Candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of an Assistant Surgeon. A Medical Certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Driving Licence, latest Driving Licence extract etc. Form of Medical certificates is available in the Notification.**

Note :- (5) **Candidates must possess a valid Driving Licence with endorsement for driving Heavy Goods vehicle / Heavy Passenger vehicle with Badge throughout all stages of selection. ie. on the last date of applications, Date of OMR test and Date of Practical Test.**

Note :- (6) Candidates included in the Short List who qualify in the Practical Test should present and produce in person the original documents for One Time Verification. Date, time and Venue of Practical Test & OTR Verification will be intimated through Profile Message and SMS in due course.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate as per G.O.(MS) No.2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority as proof of their claim ,along with the relevant documents at the time of OTR Verification.

Note:- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of OMR Test held on 26-08-2025 will be issued to those candidates who apply for the same remitting the prescribed fee after the approval of the Ranked List. No Answer Scripts are invalidated as per Notification No : ER 7-2/14/2025-KPSC DATED: 12/11/2025 of the Secretary, KPSC.
