

Date, time and Venue of One time Verification and Practical Test will be informed through Profile Message / SMS in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates must possess a valid Driving License with endorsement for driving Heavy Goods Vehicle, Heavy Passenger vehicle with badge throughout all stages of selection, i.e., on the last date for receipt of Application, Date of OMR Test and Date of Practical Test.

Note :- (7) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after the publication of entire Ranked Lists which are to be finalized on the basis of the common test.
