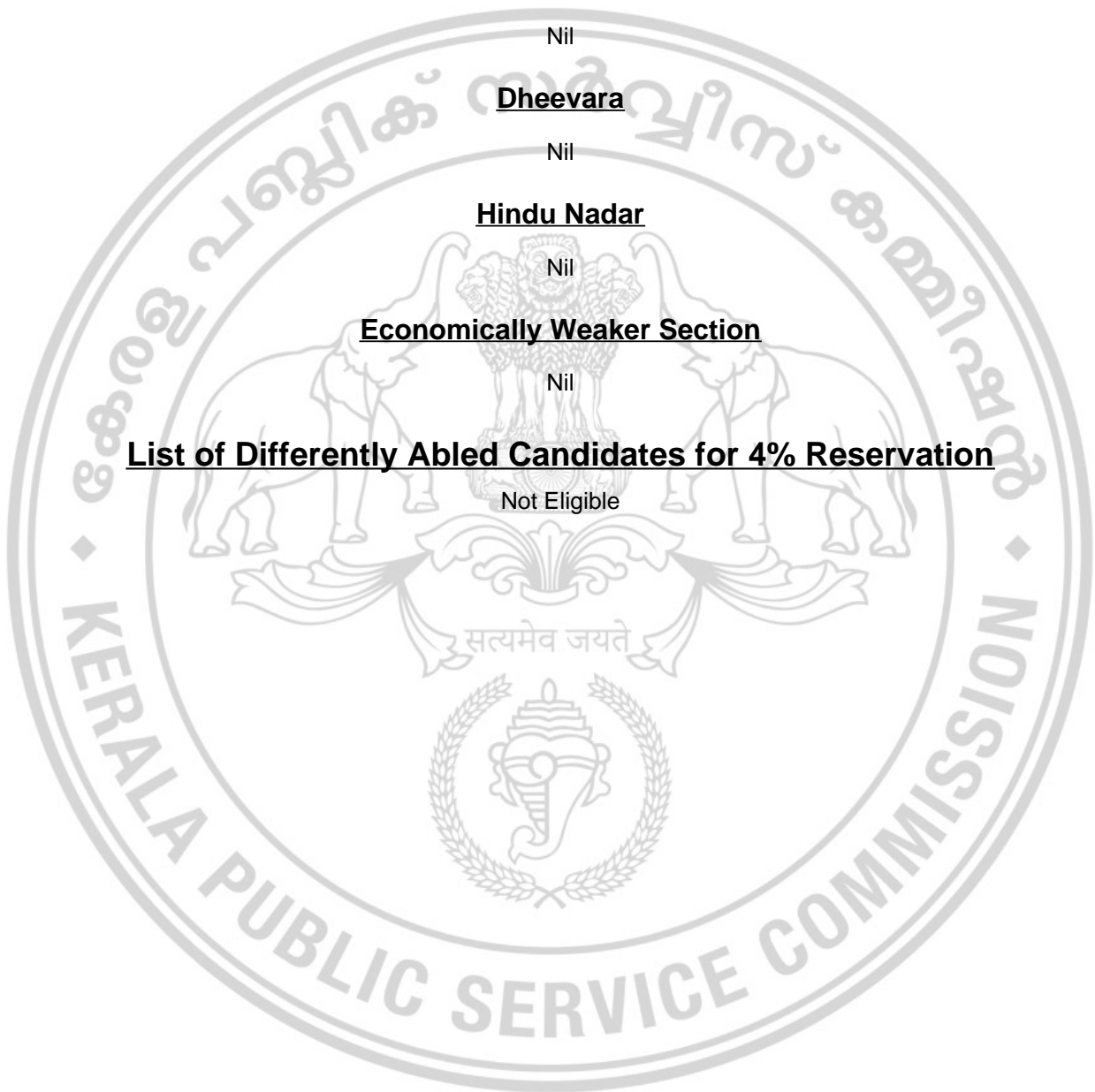

Note :- (2) Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List. The Short List has been prepared based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stages of selection. The Physical Measurement and Physical Efficiency Test, Driving Test and OTV will be conducted before the Publication of the Ranked List. The Date, Time and Venue of Physical Measurement and Physical Efficiency Test will be intimated through Profile Message and SMS in due course. The candidates should download Admission Tickets from the official website of the Commission and appear in person with their original ID proof, Medical Certificate and other required documents.

Note :- (3) Candidates must possess a valid Motor Driving licence endorsed for all types of transport vehicles (LMV, HGMV & HPMV) at all the stages of selection process ie, on the last date for receipt of Application, date of OMR Test, Physical Efficiency Test, Practical Test and OTV.

Note :- (4) All Eligible & Qualified candidates who have secured **12 (twelve)** marks and above in the OMR examination held on 26.08.2025 are included in the Main list of the Short List.

Note :- (5) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce Income and Asset Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Revenue Authority along with other relevant documents at the time of OTR Verification of original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on 26.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed Instruction will be published in the R/L to be published for the post. Candidates whose Register Numbers are invalidated are advised to refer to Notification No:ER7-2/14/2025-KPSC Dated:12/11/2025.
