Note :- (3) **10 (Ten)** candidates who have secured top marks in the Common OMR Examination held for this post on 20.09.2025 are included in the Main List of the Probability List .The mark secured by the last candidate in the Main List is **86.67 (eighty six (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes and Economically Weaker Sections, necessary Supplementary List are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated through profile message / SMS** in due course.

Note:- (5) The Register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Candidates included in the Short List belonging to **Other Backward Classes** are required to produce **Non-Creamy Layer Certificate** issued by the Village Officer as per G.O. (P) No. 81/09/SCSTDD dated 26.09.2009. **SC/ST** candidates are required to produce **Community Certificate** either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and Candidates belonging to Economically Weaker Sections are required to produce **Income and Asset Certificate** issued by the Village Officer in the format prescribed vide G.O (Ms) No. 2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other documents at the time of One Time Verification.

Note:- (8) Copy of answer scripts of the OMR Examination held on **20-09-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note:- (9) Candidates whose Register Numbers are invalidated are advised to refer to Notification No: ER 2-1/12/2025-KPSC dated 18.12.2025.
