5. The firm shall have Original Equipment Manufacturer (OEM) certified Service Engineers /Technicians.
6. The successful bidder shall provide immediate and prompt services at the earliest as the items mentioned are critical to the KPSC services and the bidder shall ensure the same.
7. If Monitor is not repairable, the same should be replaced with a new monitor or a working monitor which is not returnable. Faulty monitor will be returned.
8. If Hard Disk has to be replaced, the faulty Hard Disk will be retained by Kerala Public Service Commission.
9. Periodic Examination of computers must be carried out as a part of Preventive Maintenance in every Three (3) months.
10. Payment will be made after Certification by our Technical Experts on completion of each Six months.
11. The right to reject any quotation in full or in part without assigning any reason thereof is reserved with the Purchasing Authority.
