

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/ST/DD dated. 26.09.2009 , SC/ST Candidates are required to produce Community Certificate (Form III / Digitally Signed) issued by the Revenue Authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate vide G.O (Ms) NO.5/2020/P&EA dated 04/03/2020 issued by the Revenue Authority and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (7) Candidates included in the Probability List are required to produce Service Certificate along with other documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 15.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No. ER2-3/1 /2026- KPSC Dated: 28/01/2026.
