

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the Descriptive Test. Only those candidates who have secured 40% marks each for Papers I&II and 50% marks for Paper III (for SC/ST candidates, 30% each for Paper I & II and 35% for Paper III) have been considered.

Note :- (3) **15 (Fifteen)** candidates who have secured 40% marks each for Paper I & II and 50% marks for paper III (for SC/ST candidates 30% each for Paper I & II and 35% for paper III) marks in the Descriptive Examination are included in the Short List. The marks secured by the last candidate in the list is **257.1294 ( Two hundred fifty seven (point) one two nine four)**marks and above, subject to the condition mentioned in Note-2.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification. Date,time and Venue of OTR Verification will be published shortly.

Note :- (5) According to the existing procedure, revaluation and rechecking of answer scripts is not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The register number of candidate who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Scanned image and Tabulation sheet of Answer Scripts of the **Descriptive Tests held on 01.09.2025 and 02.09.2025** will be issued only to those candidates who had attended all the three papers who, apply for the same remitting the prescribed fee after the publication of the Ranked List.
