

Note :- (5)Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/ SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under Economically Weaker Section are required to produce EWS certificate vide GO(Ms)No.2.2020/P&ARD dt. 12/2/20 issued by Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification of original documents.

Note:- (6) The register numbers of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the probability list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on 29-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscripts are invalidated as per Notification No : ER2-3/2/2026-KPSC Dated 28.01.2026
