For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribe and Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note :- (4)** Candidates included in the Short List should present and produce in person the original documents for One Time Verification & Interview. **Date, time and Venue of OTR Verification & Interview** will be intimated through profile message & SMS in due course.

**Note :- (5)** The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

**Note :- (6)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (7)** Candidates included in the Probability List belonging to **Other Backward Classes** are required to produce **Non-Creamy Layer Certificate** issued by the Village Officer as per **G.O. (P) No. 81/09/SCSTDD dated 26.09.2009**. Candidates belonging to **SC/ST communities** are required to produce **Community Certificate** either in Form III or digitally signed certificate issued by the **Revenue Authority not below the rank of Tahasildar** and Candidates belonging to **Economically Weaker Section** are required to produce **Income and Asset Certificate** issued by the Village Officer in the format prescribed vide **G.O (MS) No. 2/2020/P&ARD dated 12.02.2020** as proof of their claim, along with other documents at the time of One Time Verification.

**Note :- (8)** Copy of answer scripts of the OMR Test held on **04-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
