No sufficient numbers of candidates are available for the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribe, Other Backward Classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification and interview will be intimated to candidates through Profile message and SMS in due course .

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO(P) No. 81/09/SCSTDD dated 26.09.2009.

Note :- (7) Copy of answer scripts of the OMR Test held on 07-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
