**Note :- (4)** Candidates included in the Short List should be present and produce in person the original documents for One Time Verification and Interview. **Date, time and Venue of OTR Verification and Interview will be published shortly.**

**Note :- (5)** According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List notification to be published for the post.

**Note :- (6)** The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

**Note :- (7)** Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by Village Officer as per G.O.(P) No. 81/2009/SC/STDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt)No.3942/2018/RD dated 24.09.2018 at the time of One Time Verification.
