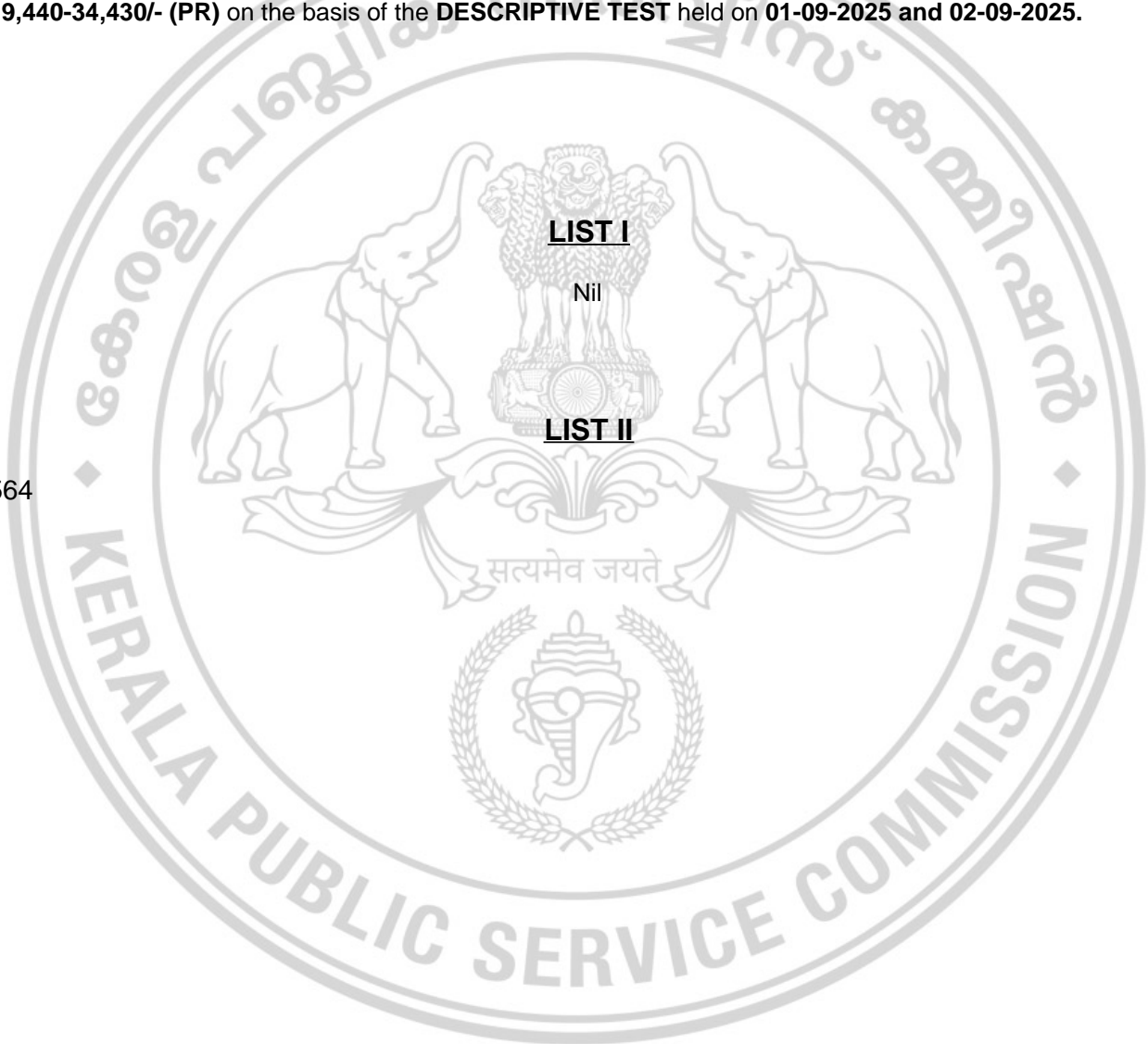

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 issued by the Revenue authority and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (8) Scanned image and Tabulation sheet of answer script of the Descriptive Test held on **01-09-2025 and 02-09-2025** will be issued only those candidates who apply for the same (only for those candidates who had attended all the three papers) remitting the prescribed fee after the publication of the Ranked List.
