Note :- (3) **20 (Twenty)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of the Short List. The marks secured by the last candidate in the Main List is **32.33 (thirty two (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Tribes, necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification** will be published shortly.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Community Certificate (Form III/Digitally signed) issued by the Revenue authority not below the rank of Tahsildar and shall produce the same along with the other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **23-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) No answer scripts are invalidated for the above mentioned post as per Notification No. ER4-2/4/2025-KPSC dtd 02.02.2026
