Note :- (5) Candidates belonging to Other Backward Classes included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(Ms)No.05/2020/P&EA dated 04.03.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (6) For Online Examination ,rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List. Detailed instructions will be furnished in the Ranked list to be published for the post.
