Note :- (6) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose Applications are found otherwise defective will be deleted from the Probability list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **27-10-2025** will be issued to those candidates who, apply for the same by remitting the prescribed fee after the publication of entire Ranked Lists that are to be finalized on the basis of the common test.
