

Note:- (5) Candidates included in the Probability List should present in person and produce the original documents for **One Time Verification. Date, time and Venue of One Time Verification will be intimated through profile message and SMS only.**

Note :- (6) Candidates included in the Probability List are required to produce latest Service Certificate in the prescribed format along with other necessary documents at the time of One Time Verification.

Note:- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found other wise defective will be deleted from the Probability list without further notice.

Note:- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of the Ranked List. Detailed instructions will be included in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on 27.10.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after the approval of the Ranked List. No Candidates have been invalidated as per Notification No : ER 16-2/10/2025-KPSC Dated:31.12.2025.
