Note :- (2) The Short list has been prepared by including eligible and qualified candidates who have secured 40% marks each for papers I and II and 50% marks for paper III (for SC/ST Candidates 30% each for paper I and Paper II & 35% for paper III) in the Descriptive Examination held on 01.09.2025, 02.09.2025. The Short List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **116 (One hundred and sixteen only)** candidates who have secured 40% marks each for papers I and II and 50% marks for paper III (for SC/ST Candidates 30% each for paper I and Paper II & 35% for paper III) marks in the Descriptive Examination are included in the shortlist. The marks secured by the last candidate in the List is **198.9983 (one hundred ninety eight (point) nine nine eight three)** subject to the condition mentioned in note (2).

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation and rechecking of answer scripts is not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 28.06.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents mentioned, at the time of OTR verification of original documents.

Note :- (7) Scanned image and Tabulation sheet of answer scripts of the Descriptive Tests held on 01.09.2025 and 02.09.2025 will be issued to those candidates who had attended all the three papers apply for the same remitting the prescribed fee after the publication of the Ranked List. No answer scripts is invalidated for the post vide Invalidation Notification No : ER4B2/3/2025-KPSC Dated 17.01.2026.
