Note :- (3) **52 (Fifty Two)** candidates who have secured topmost marks in the OMR exam held on 23.10.2025 are included in the Main List of the Short List. Marks secured by the last candidate of the Main List is **49 (Forty Nine)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribe, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification** will be intimated to candidates through Profile message and SMS in due course .

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belongs to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO(P) No. 81/09/SCSTD dated 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Thahisildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO (MS) no. 5/2020/P&EA dated 04.03.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **23-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) No answer scripts are invalidated for this post vide Invalidation Notification No. ER4-2/4/2025-KPSC dtd 02.02.2026
