Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short List has been prepared by including eligible and qualified candidates who have secured top marks in the OMR Test held on 25.11.2025. The Short List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **41 (Forty One)** candidates who have secured topmost marks in the OMR Test are included in the Main List of the Short List. The marks secured by the last candidate in the Main List is **87.33 (eighty seven (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should upload in profile and produce in person the original documents for One Time Verification and Interview. Date, Time and Venue of One Time Verification and Interview will be published in due course.

Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST Communities are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue Authority not below the rank of a Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS) No. 2/2020 P&ARD dated 12.02.2020 issued by the Village Officer in proof of their claim along with other relevant documents at the time of One Time Verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **25-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : . ER OSM-2/13/2025-KPSC dated 25/02/2026)
