

Note:- (4) Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. **Date, Time and Venue of One Time Verification will be intimated through profile message & SMS in due course.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found defective will be deleted from the Probability List without further notice.

Note :- (6) Candidates included in the Probability List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/ 09/ SCSTDD dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under Economically Weaker Section are required to produce EWS Certificate issued by the Village Officer as proof of their claim along with **Original Experience Certificate in the prescribed format as specified in the Gazette notification for the post** and other documents at the time of One Time Verification.

Note :- (7) According to the existing procedure, revaluation of answer script is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on 15.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated as per Notification No: ER2-3/1/2026-KPSC dated 28.01.2026.
