

Note:- (2) The Probability List is prepared based on the details furnished by the candidates in the application. Subsequent claims made will not be entertained at any stage.

Note:- (3) **11 (Eleven)** candidates who have secured the topmost marks in the OMR Examination are included in the Main List of this Probability List. The marks secured by the last candidate in the Main List is **91 (Ninety One)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories, if any), a necessary supplementary list is prepared by including a sufficient number of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. The date, time, and venue of OTR Verification will be published in due course.

Note:- (5) The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit, and whose applications are found otherwise defective, will be deleted from the Probability List without further notice.

Note:- (6) Candidates included in the Probability List who belong to Other Backward Classes are required to produce a Non-Creamy Layer Certificate issued by the Village Officer as per GO(P) No. 81/09/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulation of Issue of Community Certificate Rules, 2002, by the Revenue Authority not below the rank of Tahsildar, and Candidates belonging to Economically Weaker Section are required to produce Income and Asset Certificate issued by the Village Officer in the format prescribed vide G.O (MS) No. 3/2024/P&ARD dated 25.04.2024 as proof of their claim, along with other documents at the time of OTR Verification.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed, but answer scripts can be rechecked after the publication of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Copies of answer scripts of the OMR Test held on 20.09.2025 will be issued to those candidates who apply for the same by remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to the invalidation Notification No: ER 2-1/12/2025-KPSC dated 18.12.2025.
