Note:-(2) The Probability list has been prepared based on the details furnished by the candidates in their applications and subsequent claim made if any, will not be entertained at any stage.

Note:-(3) **43 (Forty Three)** candidates who have secured top most marks in the OMR Examination held on 27.10.2025 are included in the Main List of the Probability List. The marks secured by the last candidate in the Main List is **43.33 (Forty Three point Three Three)** marks. For the purpose of satisfying the rule of reservation of appointment of Scheduled Caste, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:-(4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be intimated through profile message and SMS** in due course.

Note:-(5) The register numbers of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the probability list without further notice.

Note:-(6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:-(7) Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/ SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate in Form III or digitally signed, issued by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under Economically Weaker Section are required to produce the Income and Asset certificate vide GO(Ms)No.2/2020/P&ARD dt. 12/2/20 issued by Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification of original documents.

Note:-(8) Candidates included in the Probability List are required to produce the latest Physical Fitness certificate in the prescribed format at the time of One Time Verification.

Note:-(9) Copy of answer scripts of the Common OMR Test held on **27-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :**ER16-2/10/2025-KPSC Dated: 31.12.2025** of Secretary KPSC.
