Note :- (6) Candidates included in the Short List are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-01-2026** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
