The Marks secured by the last candidate in the Main List is **38.67 Marks (Thirty Eight) Six Seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. Date,time and Venue of OTR verification and interview will be intimated through profile message and SMS.

Note :- (5) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce Income and Asset Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Revenue Authority along with other relevant documents at the time of OTR Verification of original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on **04-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-1/1/2026-KPSC dtd 20.01.2026 of the Secretary, Kerala Public Service Commission
