

SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Thahisildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per G.O(MS) No. 2/2020 P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (5) The register number of those candidates who dont produce the required documents within the prescribed timelimit and whose applications found otherwise defective will be deleted from the shortlist without further notice.

Note :- (6) For online examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the ranked list to be published for this post.
