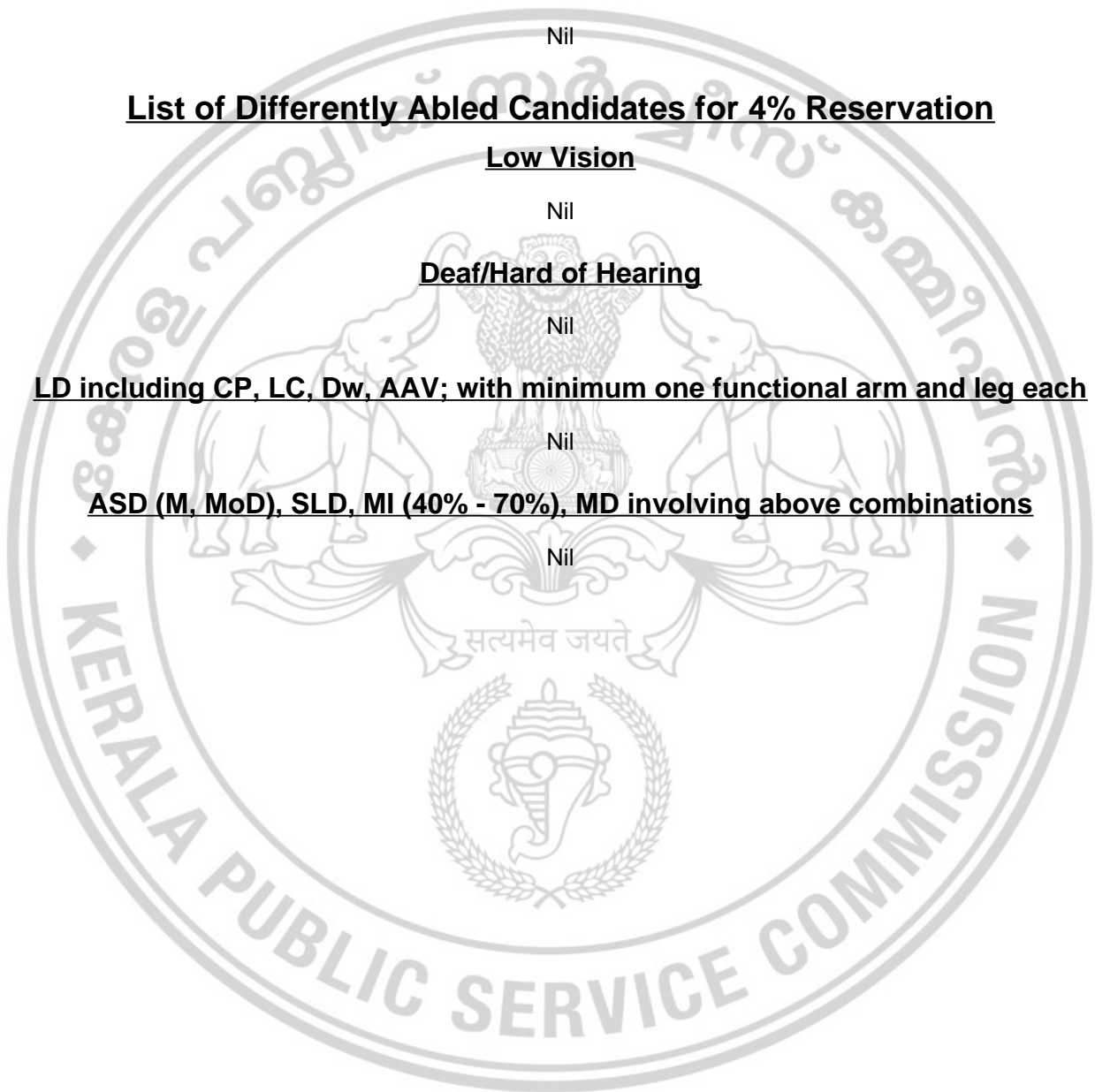

The marks secured by the last candidate in the Main List is 33 (Thirty Three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of OTR verification and interview** will be intimated through profile message and SMS in due course.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for this post.

Note :- (6) The Register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List, eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce Income and Asset Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority along with other documents at the time of interview.

Note :- (8) Copy of answer scripts of the OMR Test held on 18-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be furnished in the Ranked list to be published for this post.

Note :- (9) No Answer scripts are invalidated as per Notification No: ER 7-1/11/2025-KPSC dated 01/01/2026 of The Secretary, Kerala Public Service Commission, Thiruvananthapuram.
