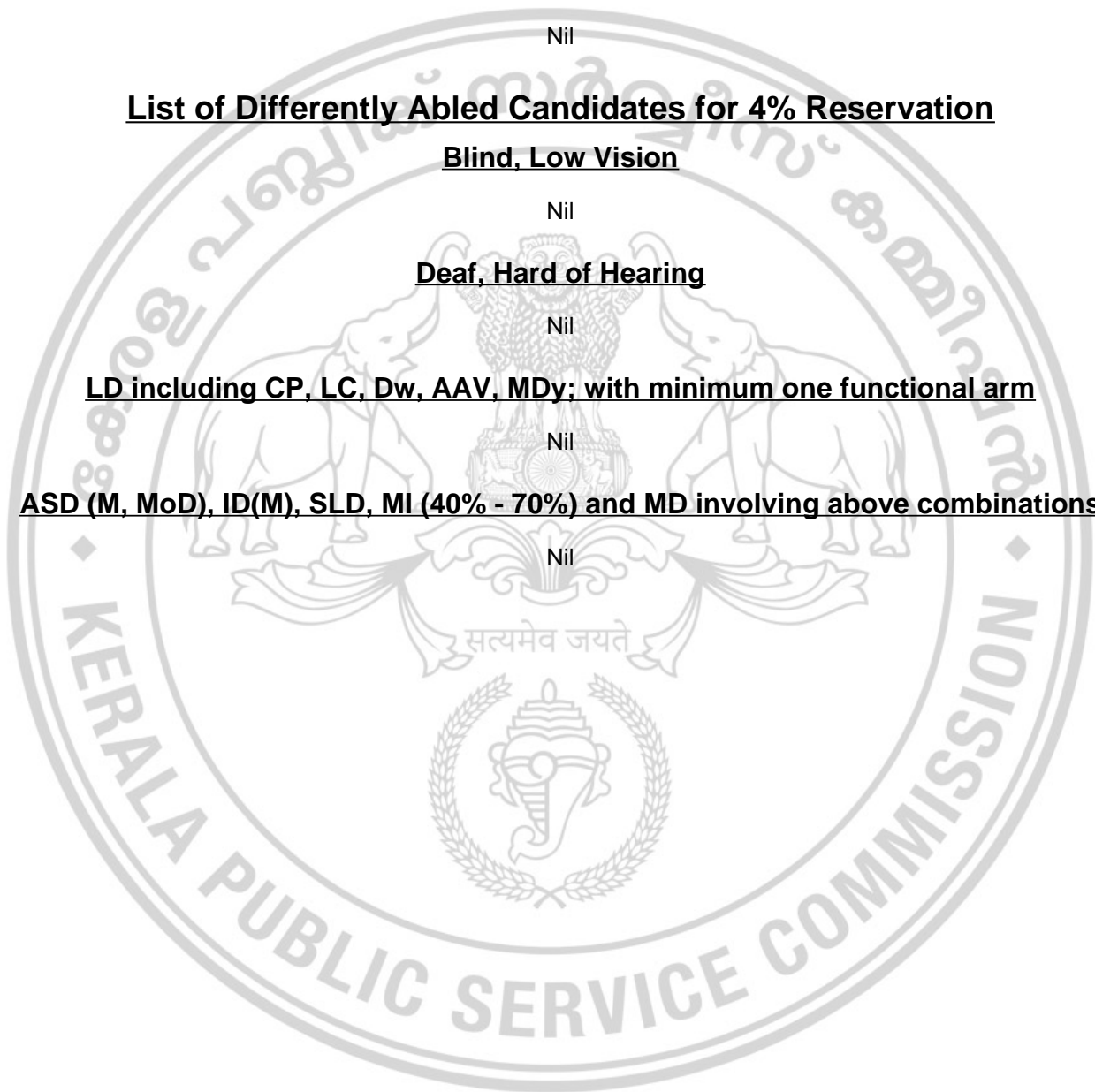

For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present in person with original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published in due course.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) At the time of One Time Verification, SC/ST Candidates included in the Probability List are required to produce Community Certificate (Form III or Digitally Signed) issued by competent Revenue Authority not below the Rank of Tahsildar, candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 and Candidates claiming reservation under EWS Category are required to produce EWS Certificate Annexure II or Annexure IV vide G.O.(M S)No.3/2024/P&ARD dated 25.04.2024, issued by the Village Officer along with other documents.

Note :- (8) Copy of answer scripts of the Common OMR Test held on **15-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-3/1/2026-KPSC Dated 28/01/2026.
