Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the eligible and qualified candidates who have secured top marks in the OMR Test, based on the details furnished by the candidate in the application for the post. Subsequent claims made will not be entertained at any stage. The Register Number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (3) 29 ( Twenty Nine ) candidates who have secured topmost marks in the OMR exam held on 16.01.2026 are included in the Main List of the Short List. Marks secured by the last candidate of the Main List is 78 ( Seventy Eight ). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribe, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification and interview will be intimated to candidates through Profile message and SMS in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belongs to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO(P) No. 81/09/SCSTDD dated 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 16.01.2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) No answer scripts are invalidated for this post vide Invalidation Notification No.ER2A2/1/2026-KPSC dated 19.03.2026.
