Note:- (2) The Probability List has been prepared based on the details furnished by the candidates in the Application and subsequent claim, if any, made will not be entertained at any stages of selection.

Note:- (3) The Main list of List - I has been prepared by including **10 (Ten)** eligible & qualified candidates who have secured top marks in the OMR Test. The marks secured by the last candidate in the main list is **27 (Twenty Seven)**. For the purpose of satisfying the rules of reservation of appointment to SC, ST, OBC, and EWS, if any, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes. List - II includes 03 (Three) lesser qualified SC Candidates & 04 lesser qualified ST Candidates with the prescribed educational qualification but no experience, who have secured top most marks among SC & ST candidates in the OMR Test. The Marks secured by the last candidate in the List-II SC category is 80.67 (Eighty (point) six seven) marks & the Marks secured by the last candidate in the List-II ST category is 49 (Forty Nine.)

Note :- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be intimated through profile message and SMS in due course.

Note:- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time and those Applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to SC/ST included in the Probability List are required to produce Community Certificate in Form III or Digitally Signed, issued by the Revenue Authority not below the rank of Tahsildar. Candidates belonging to other reservation groups are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009 and those belonging to EWS are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the competent Revenue authority at the time of OTR Verification along with relevant documents at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 29.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post. No answer scripts are invalidated as per Notification No : ER2-3/2/2026-KPSC DATED 28/01/2026.
