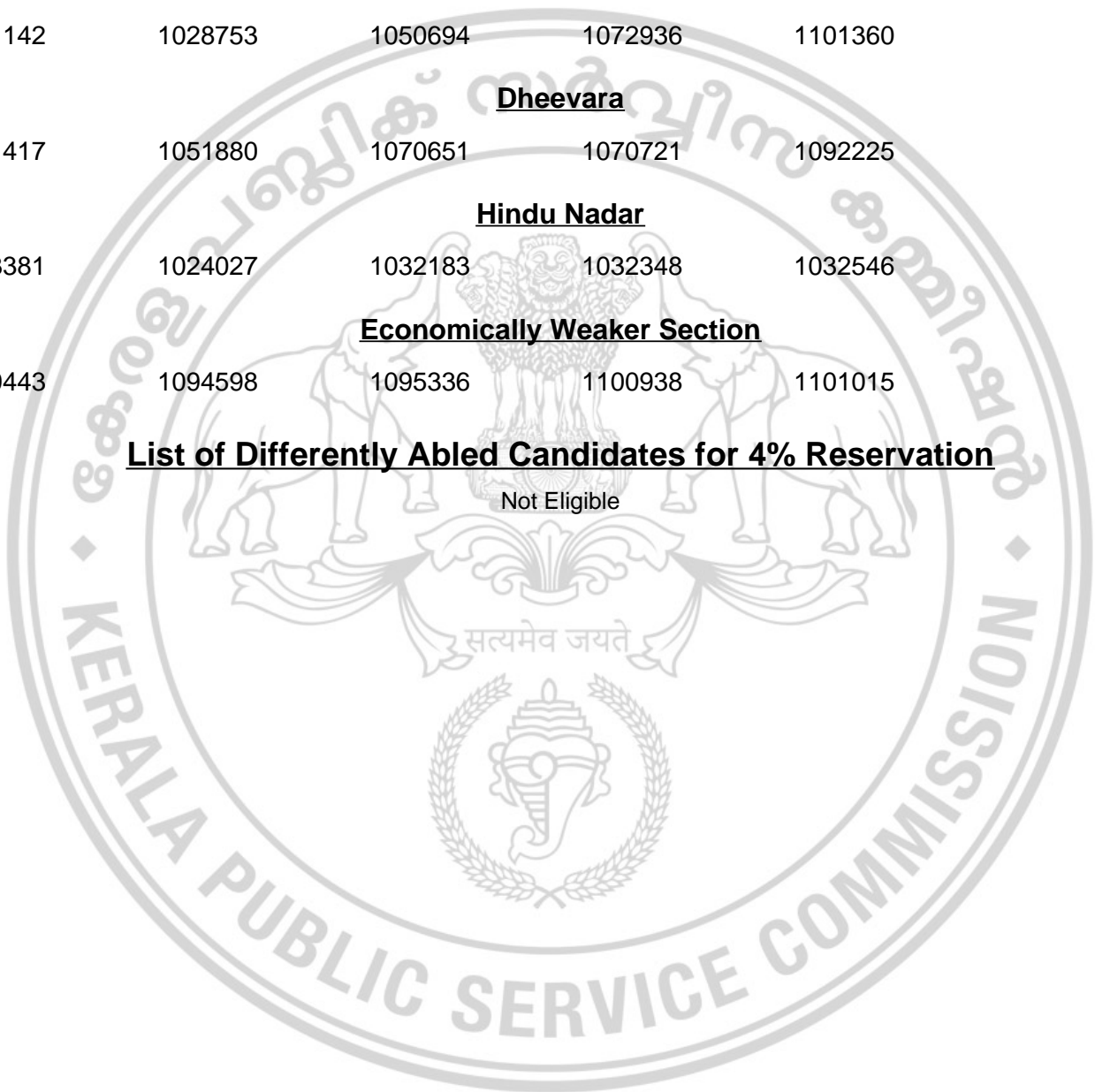

Note :- (3) **40 (Forty )** candidates who have secured top marks in the OMR test held for this post on **06-12-2025** are included in the **Mainlist** of the Short List .The marks secured by the last candidate in the mainlist is **64.33 ( sixty four (point) three three )**.For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary Lists are prepared by including sufficient numbers of candidates from lower mark range in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for Physical Measurement and Physical Efficiency Test with the original ID proof and admission ticket issued for the said test. **Date, Time and venue for the same will be intimated in due course through SMS and Profile message**. The shortlisted candidates should download their Admission Ticket for the Physical Measurement and Physical Efficiency Test from their OTR profile, logging on to the official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of Kerala Public Service Commission and appear in person with their Admission ticket, original ID Proof and Medical certificate (in the form prescribed as per the Gazette notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009. Candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally signed issued by the Revenue Authority not below the Rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce Income and Asset certificate in the format prescribed vide G.O (MS)No.02/2020 P&ARD Dated 12.02.2020 issued by the village officer as proof of their claim along with other relevant documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **06-12-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER16-2/2/2026-KPSC dated 12.02.2026 of The Secretary, KPSC Thiruvananthapuram
