Note :- (4) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, candidates belonging to SC/ST category are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) **Candidates must possess a valid Motor Driving licence endorsed for all types of transport vehicles (LMV, HGMV & HPMV) at all the stages of selection process ie, on the last date for receipt of Application, date of OMR Test, Physical Efficiency Test and Practical Test.**

Note :- (7) Copy of answer scripts of the OMR Test held on 26.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be incorporated in the Ranked List t published for the post.
