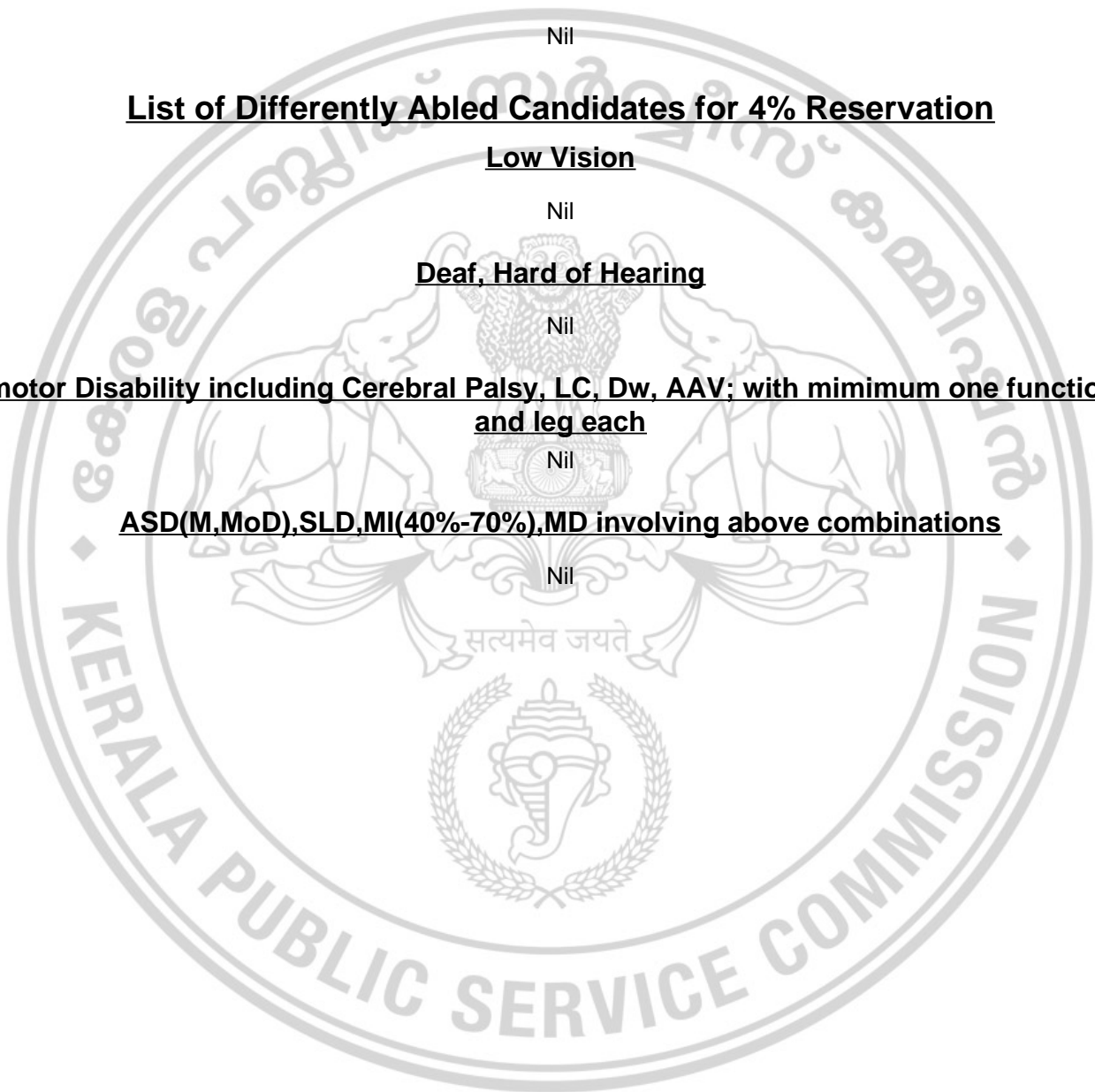

Note :- (7) Candidates included in the Short List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O. (P) No. 81/09/SCSTDD dated 26.09.2009. Candidates belonging to SC/ST communities are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and Candidates belonging to Economically Weaker Section are required to produce Income and Asset Certificate issued by the Village Officer in the format prescribed vide G.O (MS) No. 2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other documents at the time of One Time Verification.
