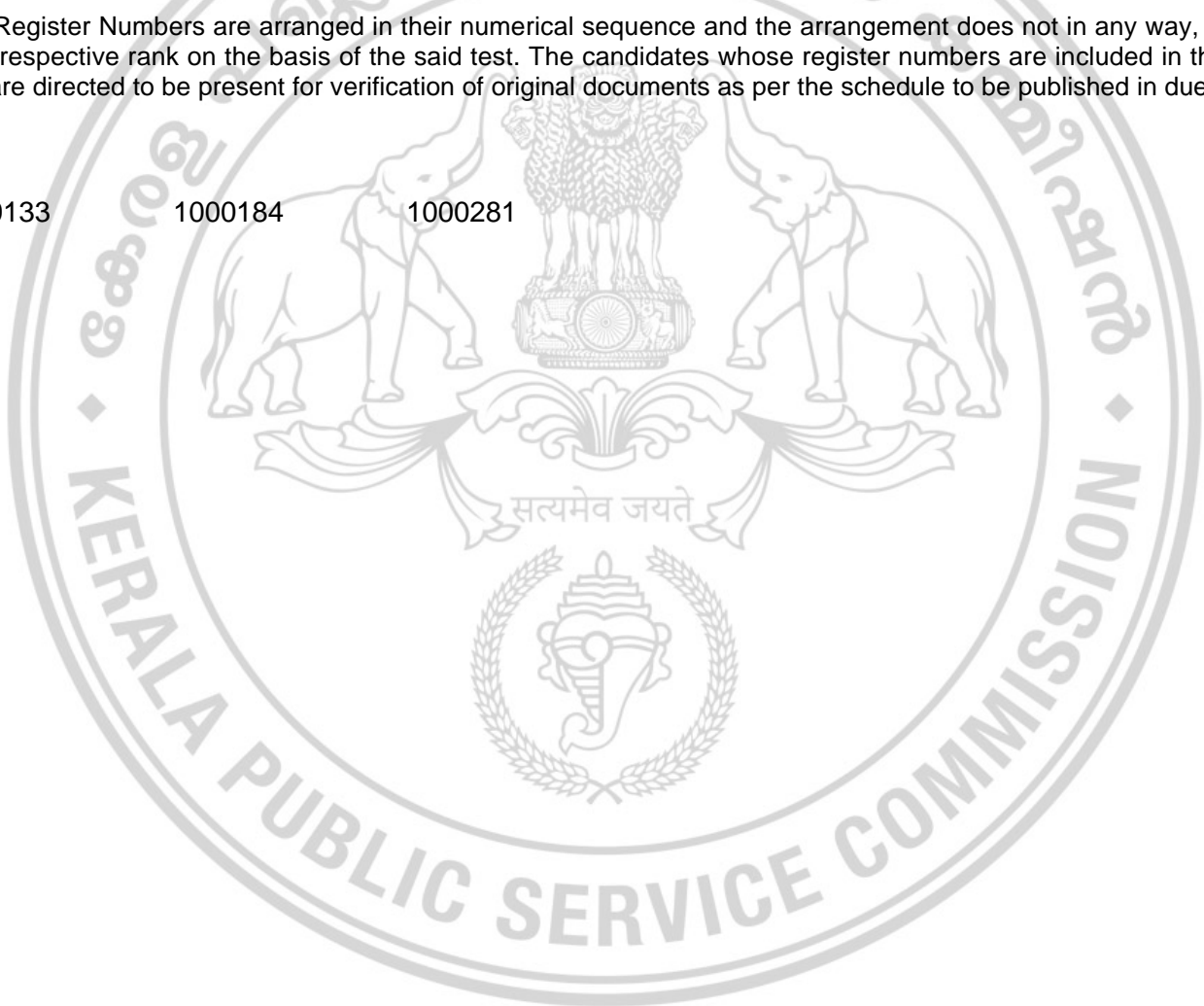

(P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Copy of answer scripts of the OMR Test held on 27-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER16-2/5/2026-KPSC-KPSC Dated 18.06.2026.
