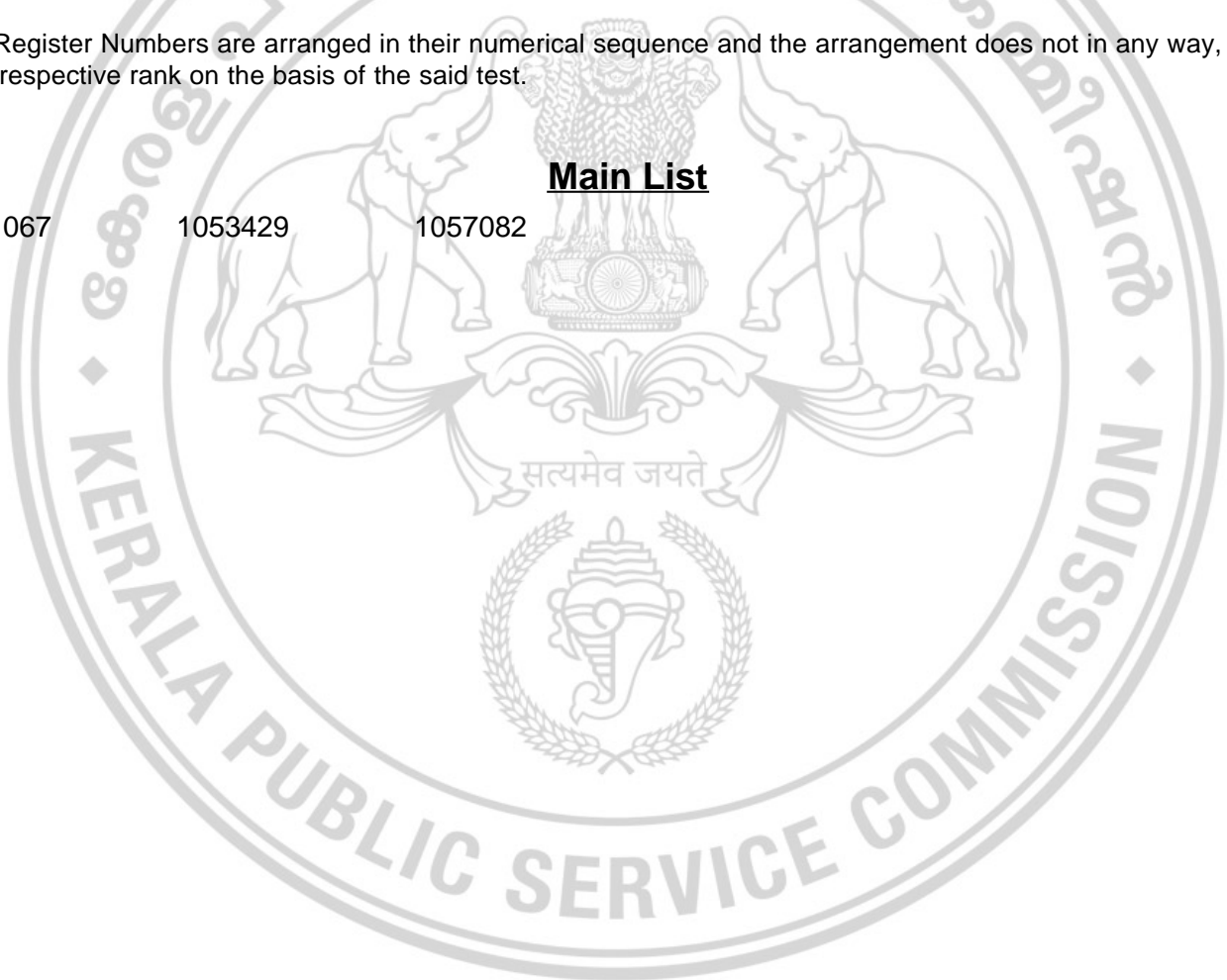

Note :- (5) Candidates included in the Short List should be present and produce in person the original documents including the latest Service Certificate as per gazette notification issued by the concerned authority at the time of One Time Verification.

Note :- (6) Copy of answer scripts of the OMR Examination held on 20-12-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No: ER16-1/1/2026-KPSC Dated 02-03-2026 of the Secretary, KPSC,Thiruvananthapuram.
