Note :- (5) According to the existing procedure, revaluation of OMR answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Copy of answer scripts of the OMR Examination held on 20-12-2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
