Note:- (2) The list has been prepared by including the register numbers of candidates who have secured the highest marks in the OMR Test.

Note:- (3) **75** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. Out of the 75 candidates in the Main List, the lowest mark secured to be included in the Main List is **37.6700 ( thirty seven (point) six seven zero zero )** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (4) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (5) Candidates included in the Short List should be present in person and produce the original documents(Admission Ticket, ID proof, Latest Driving Licence Extract, Driving Licence Medical Certificate regarding PHYSICAL FITNESS and Eye sight) for Physical Measurement and Practical Test. One Time Registration Verification after qualifying Physical Measurement and Pracical Test (T Test and Road Test). Date, Time and Venue of Physical Measurement and OTR Verification will be intimated through profile message and SMS. The shortlisted candidates should download their admission tickets for the Physical Measurement and Pracical Test from their OTR profiles..

Note:- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 /GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking)issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice..

Note: (8) Candidates must possess a valid Driving Licence with endorsement for driving Heavy Goods Vehicles and Heavy Passenger Vehicles throughout all stages of the selection process, namely on the last date of application, the date of the OMR Test, and the date of the Practical Test.

Note: (9) As per the existing procedure, revaluation of answer scripts is not permitted. However, answer scripts may be rechecked after the publication of the Ranked List. Detailed instructions regarding rechecking will be published along with the Ranked List for the post.

Note:- (10) Copy of answer scripts of the OMR Test held on 25-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer to Notification No ER 16-3/4/2026-KPSC dated 08.05.2026.
