OTR verification will be conducted after qualifying Physical Measurement and Practical Test (T Test and Road Test). **Date, Time, and Venue of Physical Measurement and OTR Verification will be intimated through profile message and SMS.** The shortlisted candidates should download their Admission Tickets for the Physical Measurement and Practical Test from their OTR profiles.

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates must possess a valid Driving Licence with endorsement for driving Heavy Goods Vehicle and Heavy Passenger Vehicle throughout all stages of selection. ie on the last date of Application, Date of OMR Test and Practical Test and also at the time of verification of original documents.

Note:- (8) Copy of answer scripts of the OMR Test held on 25-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
