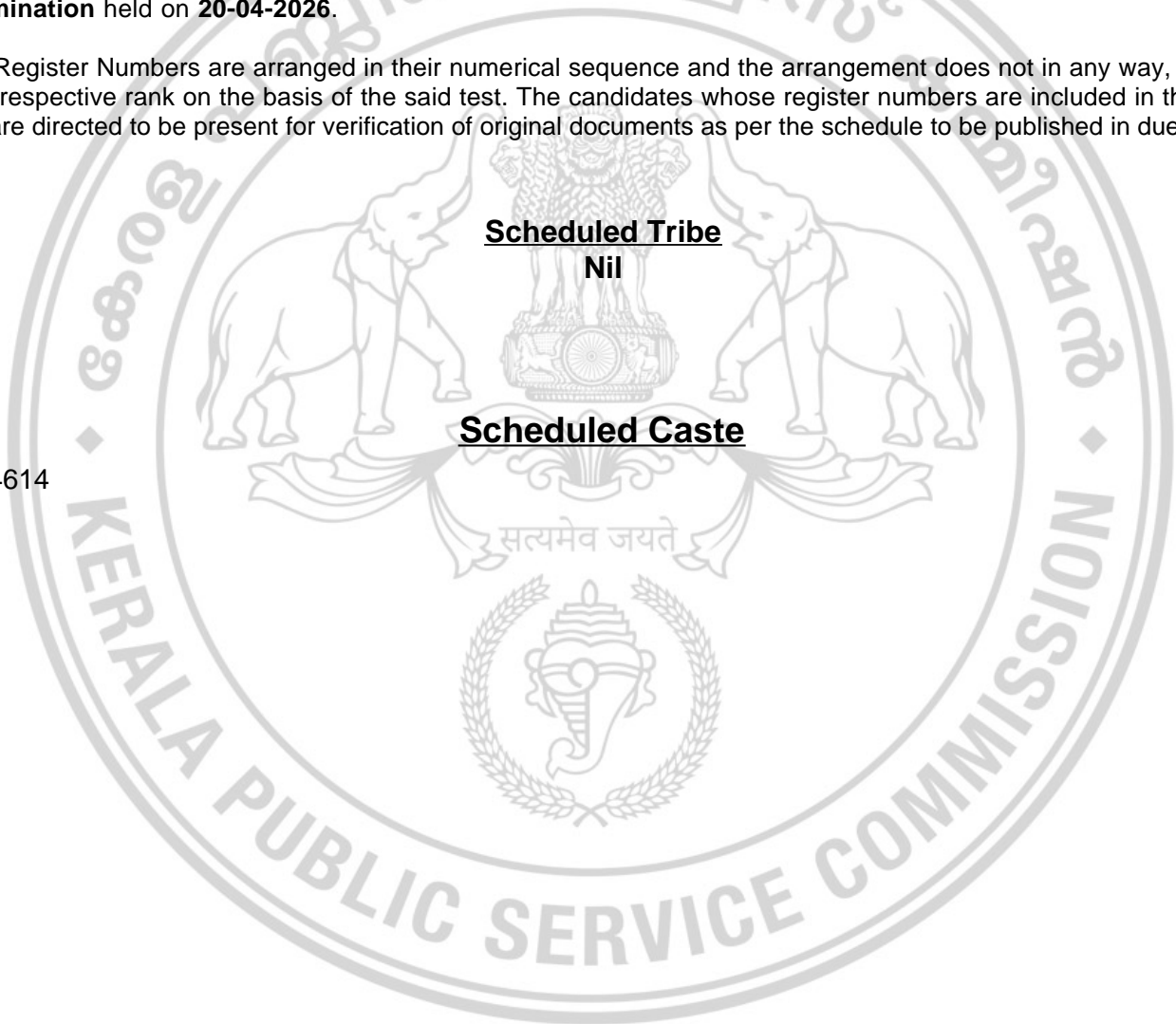

Note :- (7) Candidates included in the Short List are required to produce Community Certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on 20-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
