Note:- (3) **76** candidates who have secured top marks in the OMR examination held on 28/02/2026 are included in the Main List of this Probability List. The mark secured by the last candidate in the Main List is **26.3300 (twenty six (point) three three zero zero)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes, Economically Weaker Section (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of One Time Verification will be intimated in due course through profile Message and SMS.**

Note:- (5) The register number of those candidates who do not produce the required documents with the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 , Candidates belonging to SC/ST are required to produce Community Certificate (Form III / Digitally Signed) issued by the Revenue Authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate vide GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking) issued by the Revenue Authority along with other documents at the time of One Time Verification of original documents.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Copy of answer scripts of the OMR Test held on 28-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.No answer scripts are invalidated as per Notification No : ER1-1/4/2026-KPSC dated 06.05.2026
