The following is the list of candidates for selection to the post of **Driver Gr II (HDV) Driver Cum Office Attendant (HDV) – 1 st NCA Latin Catholic / Anglo Indian** on Rs. 25,100-57,900/- in Various (Except NCC, Tourism, Excise, Police, SWD and Transport) Department in Thiruvananthapuram District and found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancies for **Latin Catholic / Anglo Indian** Community based on the Common OMR Test held on 26.08.2025 and Driving Practical (Common) Test (T Test + Road Test) held from 24/03/2026 to 7/04/2026. **This Ranked List is brought into force with effect from 04/06/2026** and will be valid until candidates are advised and appointed against the vacancies earmarked for the **Latin Catholic / Anglo Indian** community but remains unfilled due to the paucity of **Latin Catholic / Anglo Indian** candidates during the currency of the mother Ranked List published on 18.10.2023 (Cat. No. 017/2021) for the Post.

NOTE (1): According to the existing procedure, revaluation of Answer Script is not allowed. However, Answer Scripts will be rechecked if candidates apply for rechecking through their One Time Registration profile on the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty-Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (i.e., via email, Tappal, or direct submission) will not be considered. A period of 15 (Fifteen) days will be allowed to apply for rechecking of Answer Scripts, effective from the date on which the Ranked List is uploaded on the website of the Commission (i.e., on or before 06/07/2026). Rechecking of invalidated answer scripts due to any defects will not be considered. Fee once remitted will not be refunded.

NOTE (2): Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit an online application through their One Time Registration Profile on the official website of the Commission www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and Thirty-Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days will be allowed to apply for photocopy of OMR sheets, effective from the date on which the Ranked List is uploaded on the website of the Commission (i.e., on or before 06/07/2026). A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Applications received after the prescribed date will not be entertained. Applications submitted through email, post, or in person will not be considered. Fee once remitted will not be refunded. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer sheets will be provided only after the publication of all Ranked Lists of those posts for which the candidate has participated.

NOTE (3): The entries in column (5) are based on the Communities specified by the candidate in their application forms and supported by necessary documents. Candidates whose communities have not been correctly noted in the Ranked List, as proved in their application, should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Thiruvananthapuram - 695004 within one month from the date of publication of the Ranked List to receive the benefit of the reservation to which they are entitled. In the absence of timely information regarding discrepancies, if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4): Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the District Officer, Kerala Public Service Commission, District Office, Thiruvananthapuram - 695004. The format is available on the official website of the Commission. Requests for relinquishment not submitted in the prescribed format will not be honored under any circumstances. The request must be duly attested by a Gazetted Officer of the State/Central Government with signature, name, designation, and office seal, along with a notarized affidavit and self-attested copy of an ID proof bearing a photograph as listed in the general conditions. Requests received within 15 days from the date of publication of the Ranked List on the official website will be honored against pending vacancy requisitions up to the finalization of the Ranked List. After the publication of the Ranked List, requests for relinquishment will be considered only if received on or before the date of receipt of the requisition based on which the candidate is to be advised.

NOTE (5): Since a common OMR test with common candidates was conducted for this post, the mark awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA selections, if any) which will be finalized on the basis of the common test held on 26.08.2025.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period

from the date of finalisation of the last Ranked list included in the common test.
