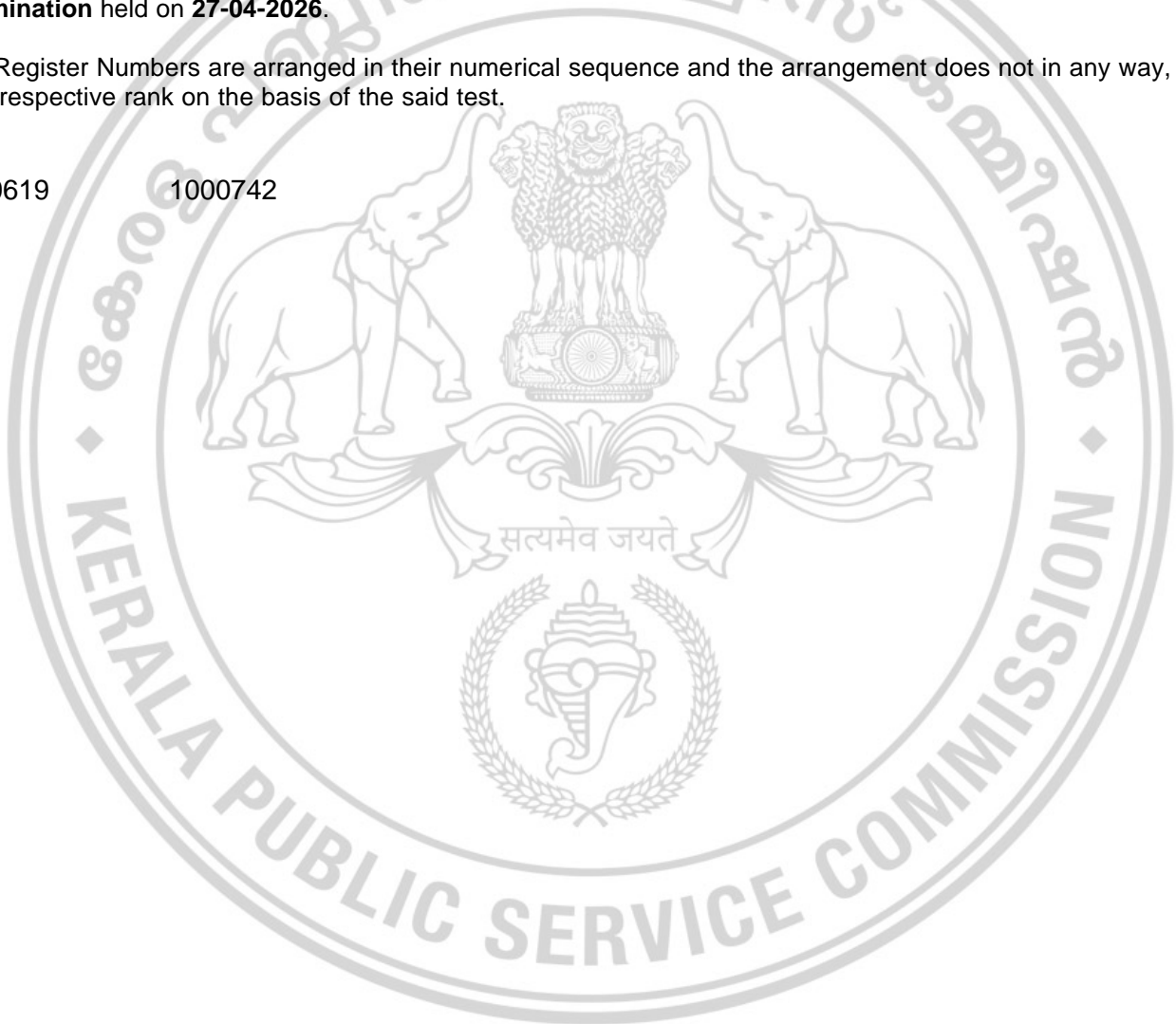

Note:- (7) Candidates included in the Short List are required to produce Community Certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents.

Note:- (8) Copy of answer scripts of the OMR Test held on 27-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No :ER16-2/5/2026 KPSC Dated 18.06.2026 of the Secretary, KPSC.
