The shortlisted candidates are directed to produce a Medical certificate (in the form prescribed as per the notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note :- (4) The Physical Measurements of candidates will be taken prior to the Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Service Certificate in the prescribed format obtained from the Head of Department or Office, showing his service particulars along with other relevent documents at the time of One Time Verification.
