Note:- (2) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (3) 70 (Thirty) candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. The lowest mark secured by the candidate who have included in the Main List of the short list is 35.33 (Thirty Five (point) three three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, time and Venue of OTR Verification and Interview will be informed through Profile message and SMS in due course.

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR are advised to refer to verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post. Copy of answer scripts of the OMR Test held on 20-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No ER7-3/5/2026-KPSC dated: 08.06.2026
