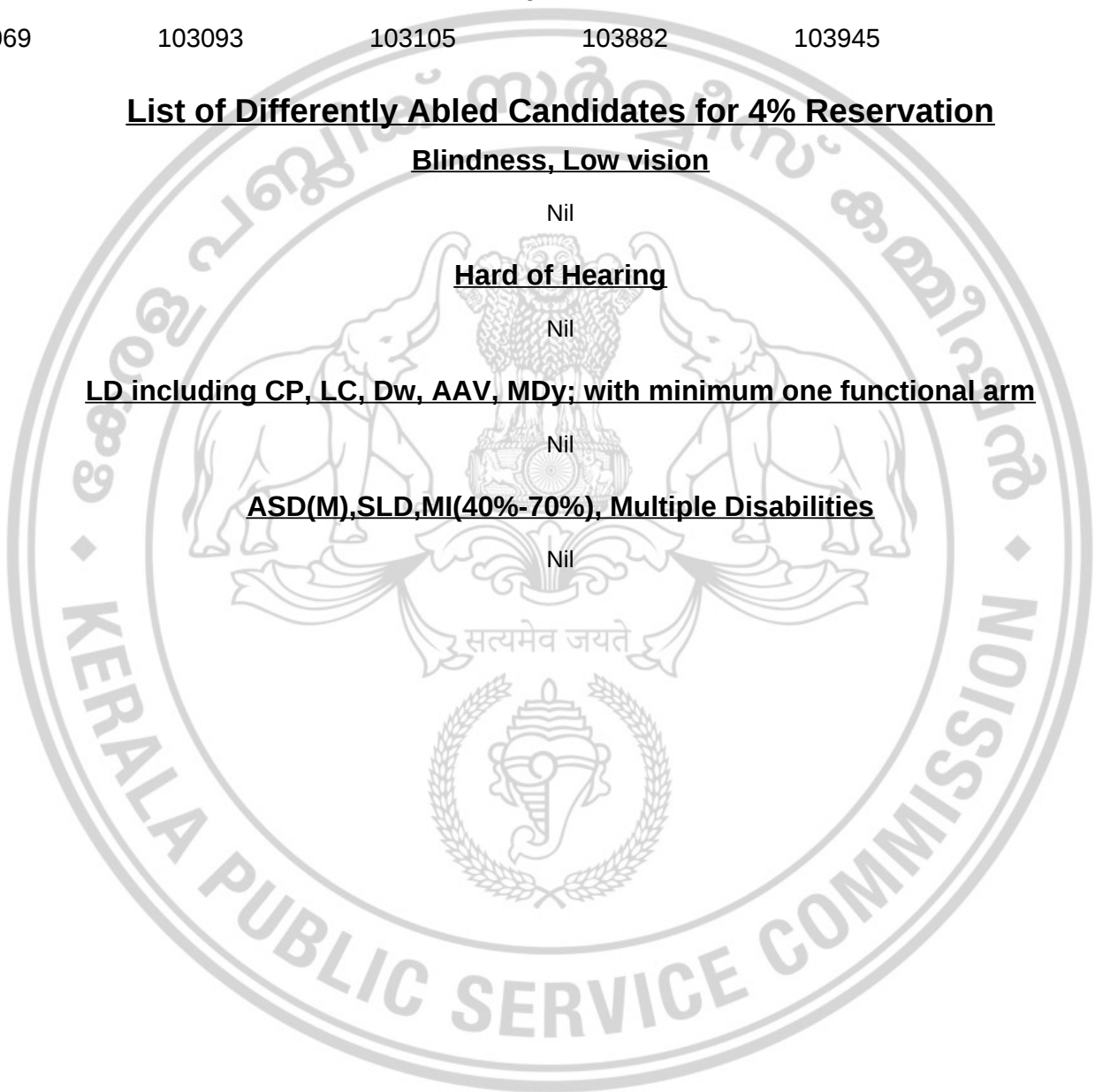

Note:- (3) 12 (Twelve) candidates who have secured top most marks in the Online Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **70.0000 (seventy (point) zero zero zero zero)**. For the purpose of satisfying rules of reservation of appointment to Scheduled Castes, Scheduled tribes, Other Backward Classes and Economically Weaker Section category, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents for **One Time Registration Verification and Interview**. Date, Time and Venue of OTR Verification and Interview will be intimated in due course through SMS/Profile Message.

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar and candidates belonging to EWS category are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with relevant documents at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose Application is found otherwise defective will be deleted from the short list without further notice.

Note:- (7) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
